*“The Committee on the Elimination of Racial Discrimination (CERD) is the body of independent experts that monitors implementation of the Convention on the Elimination of All Forms of Racial Discrimination by its State parties.*

*All States parties are obliged to submit regular reports to the Committee on how the rights are being implemented. States must report initially one year after acceding to the Convention and then every two years. The Committee examines each report and addresses its concerns and recommendations to the State party in the form of “concluding observations”.*

The 4<sup>th</sup> High-Level Dialogue on Financing for Development has been scheduled on 16 and 17 March 2010 at UN HQ in New York. This Dialogue is to focus on the theme “Monterrey Consensus and Doha Declaration on Financing for Development: status of implementation and tasks ahead”.

“The first day of the Dialogue will consist of plenary meetings chaired by the President of the General Assembly, at which ministers and high-level officials will be able to make formal statements. The second day will be devoted to three interactive multi-stakeholder round tables followed by an informal interactive dialogue with the participation of all relevant stakeholders. The themes of the 3 round tables and the interactive dialogue will be as follows:

- **Round table 1:** “The reform of the international monetary and financial system and its implications for development”;
- **Round table 2:** “The impact of the current financial and economic crisis on foreign direct investment and other private flows, external debt and international trade”;
- **Round table 3:** “The role of financial and technical development cooperation, including innovative sources of development finance, in leveraging the mobilization of domestic and international financial resources for development”;
- **Informal interactive dialogue:** “The link between financing for development and achieving the Millennium Development Goals: the road to the 2010 high-level event”.

The Dialogue will result in a summary by the President of the General Assembly.”

In the follow-up of [COP15](#), the Peoples’ World Conference on Climate Change and Mother Earth’s Rights is being organised from 19 to 22 April 2010 in Cochabamba, Bolivia.

The objectives of this world conference are to:

1. “Analyze the structural and systemic causes of climate change and propose substantive measures that facilitate the well-being of all mankind in harmony with nature.
2. Discuss and agree the draft Universal Declaration of rights of Mother Earth.
3. To agree on proposals for new commitments to the Kyoto Protocol and projects for a COP Decision under the United Nations Framework for Climate Change that will guide future actions in those countries that are engaged with life during climate change negotiation.
4. Work on the organization of a people’s world referendum on climate change.
5. Analyze and draw up a plan of action to advance the establishment of a Climate Justice Tribunal.
6. Define strategies for action and mobilization in defense of life against climate change and for mother earth rights.”
