FRAMEWORK STRATEGY PLAN

TITLE, PURPOSE, PRINCIPLES AND SCOPE OF THE WFWO

1. Section I: The TITLE of the WFWO will be:

- a) The World For World Organizations (WFWO) – Non Governmental Organization (NGO)
- b) The Executive Secretariat will be responsible for developing options for a common name that is concise and translates well into many languages and Cultures as per United Nations chart.

2. Section II: Purpose

The purpose of the WFWO is to contribute to end poverty and provide public awareness to support the Millennium Development Goals (MDGs) and its Millennium Declaration to be achieved by 2015, and implement development sustainable development programs in developing countries focusing on, food security, health, education and environmental and is to attract, manage and disburse additional resources mobilizations through a new international financial institutions and public-private partnership that will make a sustainable and significant contribution to the reduction of the poverty, education, health and sustainable development programs in developing countries in need, and contributing to poverty reduction as part of solutions to implement the Millennium Development Goals.

3. Section III: Principles

- a) The WFWO is an NGO operate internationally and supporting sustainable development programs in developing countries, financially, technically, an implementing entity trough its partners NGO / CBO nationally and internationally.
- b) The WFWO will make available the resource mobilizations mechanism trough its EBDRMT and financial and private sector partners to provides and leverage additional financial resources to combat Poverty and to contribute to MDGs objectives.

- c) The WFWO will base its work on programs that reflect national ownership and respect country-led formulation and implementation processes.
- d) The WFWO will seek to operate in a balanced manner in terms of different regions, programs and interventions.
- e) The WFWO will pursue an integrated and balanced approach covering sustainable development programs intervention prevention focusing, on poverty alleviation , health , education, drinking water, and environmental and support programs dealing with the eight Millennium Development Goals (MDGs)
- f) The WFWO will evaluate proposals through independent review processes based on the most appropriate policy and technical standards that take into account local realities and priorities of the program of the interest to the local communities in developing countries and to the WFWO target.
- g) The WFWO will seek to establish a simplified, rapid, innovative process with efficient and effective program implementation mechanisms, minimizing transaction costs and operating in a transparent and accountable manner based on clearly defined responsibilities. The WFWO will make use of existing international mechanisms of project design and implementation process taken consideration of the WFWO project cycle and design guidelines procedures.
- h) The WFWO In making its grant funding decisions, the WFWO will support proposals which:
- i) Focus on best practices by funding interventions that work and can be scaled up to reach poor people and communities including the support to local CBO and NGO affected in developing countries.
- j) Strengthen and reflect high-level, sustained political involvement and commitment in making allocations of its resources trough its partners.
- k) Support the substantial scaling up and increased coverage of proven and effective interventions, which strengthen systems for working: focusing on sustainable development programs : poverty , food security, health, education, drinking water, environmental and infrastructural sector; across NGO's, CBO, government ; and with communities.
- l) Build on complement, and coordinate with existing regional and national programs in support of national policies, priorities and partnerships, including Poverty Reduction Strategies and sector - wide approaches trough our local partner or advocacy networks.
- m) Focus on performance by linking resources to the achievement of clear, measurable and sustainable results in developing countries.

- n) Including governments, public / private partnerships, NGO's, CBO's, and civil society initiatives.
- p) Focus on the creation, development and expansion of government / private / NGO partnerships.
- q) Strengthen the participation of communities and people, including NGO's, CBO's, particularly those involved on program development proposals.
- r) Give due priority programs to the most affected countries and communities, and to those countries most poor and especially for women, men, children and vulnerable groups.

4. Section IV: SCOPE

- a) The WFWO will balance its resources by giving due priority to areas with the greatest burden of sustainable development programs, while strengthening efforts in areas with growing poverty. The Executive Board of Resource Mobilizations Team (EBDRMT) of the WFWO will be responsible for defining clear eligibility criteria within the limitations of available resources as per WFWO grant procedures and guidelines.
- b) Recognizing that the WFWO's resources will be complementary to other programs, criteria will be identified to focus the choice of activities/ programs/ projects to be supported.
- c) The WFWO will support strategies and programs that focus on clear and measurable results.
- d) The WFWO will focus its resources on increasing coverage of critical and cost-effective interventions against sustainable development programs to contribute to MDGs and its objectives and targets.
- e) The WFWO will provide grants to non-governmental (NGO), Based Community Organization (CBO) and government in developing countries to support programs, respecting country-level formulation and implementation processes as per WFWO policy, and cost - effective interventions, to support sustainable development programs in developing countries. Without binding the Board or indicating priorities, the sort of activities that could be supported, for example, are: increased access to: food security, health services, drinking water education, environments , and infrastructural services to contribute to MDGs objectives.
- f) The WFWO will support programs that:
- g) Address the Eight Millennium Development Goals Objectives (MDGs) in ways that will contribute to strengthening and to achieve the MDGs target by 2015.

h) Promote through the WFWO advocacy activities to assure that participants of the program are integral to country partnerships involving government and civil society and CBO and communities.

i) The WFWO program could support operational facilities in the context of program implementation.

j) The WFWO will intervene with emergency operations programs in the areas of emergency Aid or in post conflict, natural disasters or distress areas in developing countries needs assistance, the WFWO will develop special criteria to support special operations program for emergency aspect, through its partners.

k) The WFWO/EBDRMT will meet every in its first year and thereafter every six months or as required. In order to save cost the Executive Secretariat will arrange facilities for example. It could make use of virtual working methods and teleconferencing between meetings. Within the first two years, it is recommended that the EBD review its planning activities and resource mobilizations and operational procedures.

5. Section V: Program Financing /EBDRMT

a) The WFWO/EBDRMT should provide core funding for the Executive Secretariat, upon WFWO/EBDRMT approval of a programs plan and budget.

6. Section VI: Program Country Process

a) Basic Principles of WFWO policy and guide and country processes

b) The WFWO will base its work on programs that reflect national ownership and respect country partnership-led formulation and implementation processes.

c) The WFWO will promote partnerships among all relevant players within the country, and across all sectors of society. It will build on existing coordination mechanisms, and promote new and innovative partnerships where none exist. Through its public awareness program and advocacy supporters and partners for example, WFWO's Friends, Goodwill Ambassador for Development networks and other networks.

d) The WFWO will leverage support for innovative capacity development from other financial sources throughout the programs it supports.

e) Country Representatives Partners (CRP)

f) The WFWO will work with a CRP in close coordination and partnership mechanism that should include EBD participation on program from governments, NGOs, CBO, civil society, multilateral and bilateral agencies and the private sector. The CRP should be at the highest national level responsible

for national multi-partner and multi- sectoral development planning. It should preferably be an already existing body or individual partner. If no appropriate coordinating body exists, a new mechanism will need to be established. Where public/private partnerships do not exist, the WFWO may support alternative partnerships among NGO's and the CBO's. or local communities.

g) The Country Representatives Partners (CRP) will be the focus for program accountability, depending on the WFWO/EBDRMT decisions regarding overall WFWO accountability and fiduciary issues or activities.

h) The role and function of each CRP participant within the partnership of the development or program mechanism will be agreed upon by the EBD/CRP, safeguarding equity and transparency among the partners.

i) Proposals for funding should be submitted to the WFWO/EBDRMT. The Technical Review Panel(TRP) if is necessary, will only recommend funding for country program proposals, including, NGO's, CBO's which reflect genuine, EBDRMT participation and ownership of all interested to all communities and participants to the program proposals.

j) The WFWO/ENDRMT will also consider proposals arising from partnerships or co financing programs or grant in circumstances such as:

- 1) countries poor in developing countries;
 - 2) countries in conflict or facing natural disasters;
 - 3) countries that suppress or have not established;
- partnerships with civil society and NGOs.

k) External Monitoring and Evaluation (EM&E)

l) Monitoring at country level will be country-driven, but also linked to the WFWO's External Monitoring and evaluation (EM&E) procedures and policy.

m) The WFWO will seek to use, wherever possible, existing monitoring and evaluation mechanisms as per WFWO's EM&E procedures.

n) An independent, impartial annual assessment of progress at country level will be done.

o) The following country or regionally based entities will be eligible to receive funds (see WFWO's policy):

p) Government agencies.

r) Civil Society Organizations (including NGOs, community-based organizations, associations, etc).

s) Multilateral institutions, when requested through the WFWO advocacy to provide for trustee, operational or advisory services. Multilateral institutions will not apply directly for funding.

7. Section VII: SCOPE - Oversight External Monitoring & Evaluation (EM&E)

a) Oversight for the external monitoring and evaluation will remain the ultimate responsibility of the EBDRMT. The Board may wish to assign some responsibilities to another group (either internal or independent) to review EM&E reports submitted by grantees, and draft EM&E reports on the overall progress of the WFWO's programs. Options for who will oversee the process of monitoring programs locally, progress (on behalf of the EBD) include:

b) WFWO/EBDRMT

c) Executive Secretariat/Executive President

d) Ad hoc M&E working group

e) The Trustee (EBDRMT)

f) An independent EM&E oversight committee appointed by the Executive Board

g) Third party - accounting firm, university, etc.

h) The WFWO and its partners the new way of development business is needed so that the entire process is transparent and demonstrates an ideal partnership. Funded proposals should be made widely available to ensure this transparency and to provide models for future proposals.

i) The transaction costs of the WFWO program will need to be assessed, including the operation of the Board and Executive Secretariat, cost to produce a proposal, the review process and EM&E. This will be developed as a collaborative effort between EBDRMT and the Executive Secretariat/Executive President.
