The Summit’s main objective will be *“to build on what we have learned during the past 10 years since the adoption of the Millennium Declaration and how to accelerate progress towards the internationally agreed development goals, in particular MDGs.”* As part of the process leading to the Summit, the UN General Assembly will also *“convene interactive informal hearings with representatives of NGOs, civil society and the private sector on 14 and 15 June 2010. The outcomes of these hearings will provide an input to the preparatory process for the Summit and be issued as an Assembly document. A nomination process for speakers at the hearings has now been opened so that interested NGOs, civil society and the private sector can nominate individuals to actively participate at the event.”*
